

For Providers in Northern CA VA HCS:

1. In CPRS-GUI, go to the Consult menu and select “Consults to Other VAMCs”
2. Enter a consultation request under consult title, "TeleQuit Smoking Cessation (Palo Alto)."
3. Click box to indicate any known contraindications to bupropion or nicotine patches.
4. Click button to confirm address and phone number are correct. Update contact information, if necessary.

The TeleQuit Program provides telephone assistance and medications for smoking cessation. A TeleQuit Coordinator will contact your patient. Thank you for your referral.

No known contraindications to smoking cessation medications:

Zyban (contraindications: seizure disorder, anorexia/bulimia, recent MAOI use)

Nicotine patches (contraindications: MI within last 2 weeks, severe unstable angina)
